



Restriction requirements: (All construction material must be new.)

- 1) Chicken structures restricted to rear of owners lots.
- 2) Structures must be 20' minimum distance from side and rear lot lines
- 3) Nesting boxes must be a minimum of 36" off the ground.
- 4) Coop maximum of 8' x 8' (64 sq ft max)
- 5) Coop must be completed secured to protect chickens from predators.
- 6) Top of coop must be covered.
- 7) Run / Pen area must be 15 sq ft minimum per bird. Maximum of 20 sq ft per bird.
- 8) 4' high minimum containment fence.(Chickens can fly. Recommend 6' high minimum.)

AMENDMENT X OF HARBOR POINT SUBDIVISION RESTRICTIONS SECTION I AND II

AMENDMENT X effective September 1, 2023 of Harbor Point Subdivision Restrictions. These restrictions were established August 8, 1979 and are filed in volume 4, Page 57 of the Plat records of Brown County (#6088).

Paragraph 8 Section I and Paragraph 6 Section II is amended in its entirety as follows: No animals or birds except for chickens (hens only; maximum of 4 up to 1 acre), other than household pets, shall be kept on any lot. All animals shall be contained either by fence or leash on lots that you own. There shall be no animals such as horses, cows, goats, sheep or hogs.

Rules for chickens: Owners must have Architectural approval and sign a contract acknowledging the rules, regulations, restrictions, and entrance onto property. Restricted to rear lot yards, 20 feet from rear and side lot lines. Coop is to be 36 inches off ground, minimum of 4 feet. containment fence, maximum 8 feet, 360 degrees, all sides and top must be fenced and covered. Coop area must be secured so no wild animals of any kind can enter coop area. Coops must be made of new material. Minimum inside of coop, 4 square feet per bird, 15 square feet per bird in run area/pen, not exceed 20 square feet max per bird. Coop must be kept clean and always maintained. No chicken caraccas, waste or feces can be dumped in HPOA dumpsters. HPOA has the right to enter to property to cure violations. Any chicken that is loose, coop violations, non-prior approval architect form, and any/all chicken restrictions that are violated are subject to a \$500.00 fine and immediate seizure of chickens.
